

Finance agreement for the enrolment of category II students.

Approved by the Board of Administration for the School-Year 2020-2021.

Given that

- The “Scuola per l’Europa di Parma” is an institution of special regulations with legal status of public domain and independent administration, financial and patrimonial, associated to the European School system from whom it adopts their regulations, programmes, teaching model and administrative model (article 1, clause 1, regulation 3rd August 2009, n. 115);
- The inter-ministerial decree 18th June 2010, n.138 “Administrative Regulation of the “Scuola per l’Europa di Parma”, at article 15 provides that for the purpose of admission to the school the students are divided into three categories:
 - cat. I children of employees of EFSA and of other European Institutions (that have priority of admittance to the school);
 - cat. II children of employees of firms and/or institutions that have established agreements with the school.
 - Cat. 3 children of Italian and non Italian parents that have chosen to attend the school for whom admission is subordinate to the places available;And in accordance with organisations that contribute to school finances, as established in article 6, subparagraph 7, letter c) that the school Board of Administration authorizes the agreement with organisations that contribute to school finances, as established in article 26, subparagraph 1, letter e);

The “Scuola per l’Europa di Parma”

And

Stipulate

The herewith agreement of finance to contribute to the functioning of The “Scuola per l’Europa di Parma”, obtaining the right of enrolment for the children of their employees.

Article 1

The Firm _____ that contributes to the functioning of The “Scuola per l’Europa di Parma” will hereafter be referred to as “The Firm” and The “Scuola per l’Europa di Parma” as “The School”.

Article 2

The School has established that the Firms that wish to enrol the children of their employees and to contribute to the functioning of the school must pay a part of contribution per capita, in addition to the annual school fee for students of category III.

Article 3

The one-time payment is set at 3,500 (three thousand and five hundred) Euros, regardless of the number of employees of the Firm, to be paid for each student at the time of his/her first enrolment, in order to establish a right of admission to the school; compared to students of category III the agreement can be granted subject to the school organisation, to the criteria adopted on enrolment, and to annual revision.

Within category II preference will be given to the children of employees coming from abroad.

The maximum payment percentage for the students of category II is fixed at 50% with respect the places available after the enrolment of students of category I.

The payment of 3,500 Euros is in addition to the annual school fee, for enrolment and attendance of the school as determined by the Board of Administration, which must be paid by the students’ parents for the first and successive years.

Article 4

The added fees must be paid by the Firm at the time of the first enrolment, and not more than 15 days after the closure of the enrolment date. If this is not done, the student has no prior rights in the acceptance of enrolment.

Article 5

The agreement is undersigned by the Firm for the amount of 3,500 Euros with regard to the student _____ class _____
